## POLICY/REQUIREMENTS

- Once accepted all vendors will need to provide a certificate of liability Insurance naming the Port Credit Business Association/Busker Fest and the City of Mississauga, with a \$2,000,000.00 liability coverage. I can provide you with insurance if you need it.
- **Cancellations** are to be received in writing 30 days prior to the event. A cancellation fee of \$75.00 will apply.
- All vendors must provide their own set-up such us: tent, tables and chairs (**weights to hold tents down are a must**)
- All vendors must have a Mississauga Vendor Permit please include \$54.00 with your space fee.
- All vendors may drive into the park to unload their vehicle. Once unloaded vehicles must go park at the far end of the Port Credit Memorial Arena.
- All vendor spaces are 10'x10' and have limited access to power, please bring 100ft extension and power bar as you will all share power. **1 circuit 15amp. If you require more than provided you will need to bring your own quiet generator. Or extra fee will apply.**
- Vendors will be required to maintain their area clean as well as to clean up at the end of the event. All vendors commit to open during set hours.
- Busker Fest and PCBIA reserve the right to pick and choose the vendor as well as to limit the number of vendors and choose appropriate location according to vendor needs.

Please make sure to read all the rules and regulations before signing the agreement, space is limited so please submit your application as soon as possible.

Applications without payment or waiver signed are not considered complete and priority will be given to complete applications. Application deadline is: **June 15, 2018 or when full.**
